- THE MAIN PURPOSE OF THE POLICY IS TO GUARANTEE THE MANUFACTURE AND CONTINUOUS IMPROVEMENT OF THE QUALITY AND FOOD SAFETY SYSTEM, MANUFACTURING SAFE PRODUCTS AND SERVICES IN ACCORDANCE WITH THE SPECIFICATIONS IN FORCE AT THE TIME, IN A MANNER WHICH SATISFIES OUR CLIENTS' REQUIREMENTS AND IN COMPLIANCE WITH SPECIFICATIONS IN RELATION TO QUALITY, FOOD SAFETY AND LEGAL REQUIREMENTS.
